Meeting called to order by President Lawrence Jones.

Prayer

District 3 Police reporting by Officer Gibson

- Explanation of police stats – there were robbery increases over the last month
- Contact information is included in the packet – call directly or use Fix It Cincy to make reports
- Police investigated reports of dumping in North Fairmount but didn't see any upon arrival.
- Police investigated reports of on street auto work issues on Pulte Street but did not witness any upon arrival.
- The dumping behind New York Deli seems to have abated.
- Speaking to residents in person is beneficial to understanding neighborhood and community policing needs.
- Officer Gibson requested information about speed humps installation on Baltimore and flashing stop signs on Seegar & Baltimore from Pamela Adams.
- Residents in attendance report that there are car races happening on Carll Street.
- Residents in attendance request to have a speeding/light test run on Baltimore near the school.
- Officer Gibson explained that the speed test can be moved to different areas around the neighborhood.
- Residents present request more police presence in the areas of Baltimore/Beekman/Carll Street.
- Residents present asked if police can stop to fill out paperwork in different areas around the neighborhood to assist with additional presence.
